STAFF REPORT

Jessica Amen, Support Staff

New District 3 Commissioner Varela is joining us today.

All commissioners introduced themselves and their work professions.

Quorum: To determine if in-person meetings of the commission will be held. Commissioners who intend to participate virtually must inform Support Staff beforehand.

Emergency order: According to Director Watkins-Tartt, all public health meetings can now be attended in person or online by the public, who also have the option to participate in person.

All Bill of Lists must be forwarded to all commissioners not only HEiAP Commissioners.

March PHC meeting will be held at CVUSD.

Many Commissioners preferred PHC Meeting to be close to Bart station (San Leandro), making it more accessible to the public as well.

Chair Castillo advised commissioners that are not involved with subcommittees to join.

Update for March agenda: Steering Committee brings it up.

Commissioner Budge wants to see a potential presentation on either HIV or STi (Will not be at the PHC March meeting) specifically: Community program, and epidemiology data on HIV (prep) health disparities. Also,

Commissioner Budge will like to know more about program funding, and how they use that for like community clinics, or if there are community clinics that they partner with. Alameda County HIV landscape. This will be on the April PHC Meeting agenda.

Commissioner Bhaiji will like to know more about Medicaid and Medicare enrollment process. This will be on the April PHC Meeting agenda.

DIRECTOR'S REPORT:

The report is mostly on COVID because a lot of things are coming up regarding change. Director Watkins-Tartt gave a Covid report update.

Epidemic Data Key Points:

- Daily reported COVID-19 cases rate now flat after 2 month decline
- 95 hospitalized, 8 ICU
- The wastewater signal is mixed.
- Alameda County in CDC "Low" COVID-19 Community Level
- Flu and RSV situations improved.
 Conditions are substantially better than in the prior two winters.

What can residents do about COVID-19 and other respiratory viruses?

- Stay home when sick.
- Stay up to date on vaccinations.
- Keep gatherings smaller and outside or well-ventilated.
- Wear masks for greater protection.
- Test for COVID-19.
- Have the plan to get treatment.

What to expect going forward:

- Emergencies are ending but COVID-19 will remain part of our lives.
- Greatest risk is for the older adult and those with serious health conditions.
- New variants will emerge.
- Our understanding of the short and long-term impacts of infection will grow.
- Treatments and vaccination strategies should continue to evolve.
- Public health strategies may come to resemble those for influenza.

- Reduced Ongoing Services
- o Focus on Infection Prevention & Outbreak Guidance
- o Supporting LTCFs and other vulnerable congregate settings
- Treatment Education and Outreach will shift to provider education.
- o Community Vaccinations, popups, in Home Vaccinations
- o Community Testing with increased Outreach and education
- Coordination with Community Partners
- Community Support/Referrals will transition into PH Nursing
- Dashboards, Data Management streamlined.
- Therapeutic Coordination

Optum Serve Testing Site Updates

- San Leandro Marina Community Center closed permanently on 1/22/23.
- Mobile testing bus shut down on 2/5/23.
- Optum serves San Pablo Park, 2800 Street, Berkeley will close permanently on 2/28/23.

Community Testing Services Continue

- 10 Testing Vendors
- 22 Stationary Sites
- Hosting 61 Events per week including mobile events
- Rapid Testing, PCR testing, and At Home Kit Distribution + COVID Care information
- Co-location of services, resources with vaccination and basic needs whenever possible
- LaClinica and La Familia currently still support access to treatment.
- Target population: uninsured/underinsured, communities most impacted by COVID/racial/health disparities.
