FY2023-2024 Proposed State Budget Overview

• \$297B total budget (\$223.6B GF)

- \$22.5B shortfall predicted (LAO estimates \$25B)
- May be higher. The tax deadline extended until October, the full fiscal picture is unknown.
- Small number of new proposals/initiatives, prioritizes sustaining key investments while closing the budget gap, including HCSA priorities such as:
- Expanding Health Care Access and Health Care Delivery Transformation
- Expanding the Behavioral Health Continuum
- Improving Services for the Developmentally Disabled
- Reproductive Health Services
- Investments in Homelessness and Affordable Housing
- Reduces/Delays some key investments including in Public Health Workforce (Public HERO initiative), and other health workforce proposals.
- Some reductions may be restored if there is sufficient General Fund in January 2024

FY2023-2024 Budget: Public Health

- **Public Health Infrastructure Investment** Maintains \$300M ongoing General Fund to modernize state and local public health infrastructure and transition to a resilient public health system.
- **Public Health Climate and Health Resilience Planning**—Reduces \$25M General Fund in FY 2022-23, eliminating the program. If there is sufficient General Fund in January 2024, this reduction will be restored.
- **Partial Public Health Workforce Reductions**—Reduction of \$49.8M General Fund over four years for various public health workforce training and development programs to help address the budgetary problem, resulting in only a \$15.8M investment over four years for workforce development programs.

FY2023-2024 Budget: CalAIM

- Maintains approximately \$10B total funds commitment to continue transforming the health care delivery system through California Advancing and Innovating Medi-Cal (CalAIM).
- CalAIM Transitional Rent Waiver Amendment —\$17.9M (\$6.3M General Fund) in FY 2025-26 increasing to \$116.6M (\$40.8M General Fund) at full implementation to allow up to six months of rent or temporary housing to eligible individuals experiencing homelessness or at risk of homelessness and transitioning out of institutional levels of care, a correctional facility, or the foster care system and who are at risk of inpatient hospitalization or emergency department visits.

Justice-Involved —\$109.7M (\$39.1M General Fund) in FY 2023-24 for the CalAIM inmate pre-release program.

Shannon Benson's presentation on Front Door Organizer

Public Health nursing division, a new program served as a front door. Resource and central referral unit for providers, communities, organizations, individuals, and families. They've come because folks are uninformed of available programs and services. They wish to help residents with their fundamental resource

needs. They want to be able to provide a client profile. Residents frequently require essential resources such as health insurance, medical care, food, public assistance, transportation, housing, aid, housing, assistance, housing, assistance, Covid information, and numerous social needs. She noted that citizens in many of the places we serve are frequently unaware of government-funded programs that can help them. Our team will provide information, assistance, and connections to access resources, as well as support. Service navigation can be hard, difficult, and intimidating at times. The front door will be a program that tries to bridge the knowledge-access gap by directing people to helpful, use suitable resources such as social services, public assistance, behavioral health care, and mental health care. And the reason she's presenting to the Public Health Commission is that they're attempting to name the front door, and I'm coming to the commission to beg for help. She mentioned several names that they had discussed in the past. Mrs. Benson invited the Public Health Commissioners to vote using the MENTI app to select a name that they believe will be the best match for this program, and all commissioners participated accordingly.
